A BILL

For an ordinance authorizing expenditures in the Human Services Special Revenue Fund based on a letter of intent from State of Colorado to award funding for the "Community Services Block Grant (CSBG) FY2019" program.

WHEREAS, the State of Colorado awards Community Services Block Grant funds to the City and County of Denver annually; and

WHEREAS, the State of Colorado Department of Local Affairs has sent a letter of intent (LOI) to the Mayor's Office stating their intent to provide a CSBG FY2019 award in the amount of \$890,700 for CSBG funded projects; and

WHEREAS, the City and County of Denver has given due consideration to said letter of intent, a copy of which is duly filed with the City Clerk, Filing No. 20180576;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Expenditures are hereby authorized from the Human Services Special Revenue Fund, Accounting No. 13000, the amounts of money in the following tabulation to be expended for the purposes and upon the authorizations in said Ordinance set forth:
