**A BILL**

**For an ordinance making a rescission from and an appropriation in the Culture and Recreation Special Revenue Fund Series to make a cash transfer to Parks Legacy Capital Improvement Funds.**

**WHEREAS**, in 2018, Denver voters approved Ballot Measure 2A, which increased the sales tax rate by 0.25 percentage points starting January 1, 2019, to be spent on various programs and projects that support Parks, Trails and Open Space: and

**WHEREAS**, the Department of Parks and Recreation (DPR) has identified funding gaps in several projects driven by escalating construction costs: and

**WHEREAS**, the DPR would like to kickstart the Citywide Pickleball Deployment Project; and

**WHEREAS**, the City desires to transfer cash from the Parks Legacy Special Revenue Fund to Parks Legacy Capital Improvement Projects Funds to maintain scope of work for current projects and not delay projects due to escalating costs;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the Culture and Recreation Special Revenue Fund, Accounting No. 15000, listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
