5 **A BILL**

6 **For an ordinance authorizing cash transfers to and making appropriations**  
7 **from the Colorado Convention Center Capital Fund.**  
8

9 **WHEREAS**, the Colorado Convention Center has approximately one million visitors  
10 annually and continues host new conventions and events; and

11 **WHEREAS**, the Colorado Convention Center conveyance systems of escalators and  
12 elevators are nearing the end of useful life and need replacement to support continued growth of  
13 the Colorado Convention Center;  
14

15 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
16 **OF DENVER:**

18 **Section 1.** There is hereby authorized the transfer of cash from the Convention Center Hotel  
19 Special Revenue Fund to the "Colorado Convention Center" Capital Fund in the Grant and Other  
20 Money Projects Fund the amount indicated in the following tabulation:

22 The foregoing transfer will be used to align the budget for the "Colorado Convention Center" Capital  
23 Fund with the amounts required for the Certificate of Participation (COP) payment schedule.

24 **Section 2.** There is hereby authorized the transfer of cash from the Entertainment and Cultural  
25 Capital Projects Fund to the "Colorado Convention Center" Capital Fund in the Grant and Other  
26 Money Projects Fund the amount indicated in the following tabulation:

2 reserve to support payments required for the COP but are no longer needed for said purpose and  
3 can be directed to other needs at the Colorado Convention Center.

4 **Section 3.** There is hereby authorized the transfer of cash from the Convention Center  
5 Replacement Fund to the "Colorado Convention Center" Capital Fund in the Grant and Other Money  
6 Projects Fund the amount indicated in the following tabulation:

8 The foregoing transfer reflects the investment earnings from the Convention Center Replacement  
9 Fund and will be used by the Colorado Convention Center Capital Fund for capital maintenance.

10 **Section 4.** From the Grant Projects Fund, Accounting No. 38000, out of monies transferred in  
11 Sections 2 and 3 and monies not otherwise appropriated and in addition to amounts heretofore  
12 appropriated by Ordinance No. 1237, Series of 2017, and any supplemental appropriations or  
13 rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the  
14 amount of money following such designation, to be expended for the purposes and upon the  
15 authorizations in said Ordinance set forth:
