5 **Laying out, opening and establishing as part of the City street system parcels of**
6 **land as: 1) Public Alley, bounded by East 22nd Avenue, North Holly Street, East**
7 **23rd Avenue, and North Hudson Street; 2) Public Alley, bounded by East 22nd**
8 **Avenue, North Grape Street, East 23rd Avenue, and North Glencoe Street; and**
9 **3) Public Alley, bounded by East 22nd Avenue, North Forest Street, East 23rd**
10 **Avenue, and North Fairfax Street.**

11 **WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of
12 the City and County of Denver has found and determined that the public use, convenience and
13 necessity require the laying out, opening and establishing as public alleys designated as part of the
14 system of thoroughfares of the municipality those portions of real property hereinafter more
15 particularly described, and, subject to approval by resolution has laid out, opened and established
16 the same as public alleys;

17 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**
