A BILL

For an ordinance making a supplemental appropriation in the Denver Arts and Venues Special Revenue Fund.

WHEREAS, Denver Arts and Venues’ events and attendees have exceeded what was budgeted for 2023, resulting in increased revenue and requiring additional appropriation to support event spending;



NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From the Denver Arts and Venues Special Revenue Fund, Accounting No. 15000 not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1446, Series of 2022, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
