- Amount: Revenue Contract
- Term: 10 years
- Purpose: Build, operate, and maintain electric vehicle (EV) chargers to expand availability at DEN and support greenhouse gas (GHG) emissions reduction goals

# CONTRACT OVERVIEW



- DEN is looking to partner with EVerged to expand and upgrade electric vehicle (EV) charging stations on airport property, with EVerged responsible for design, installation, operation, and maintenance.
- More EV chargers will provide drivers convenient options at DEN, support cleaner air and Net Zero goals, and be installed in public parking lots, employee lots, and other strategic locations.
- EVerged will design, fund, install, and operate the charging system, while DEN manages site approval, parking enforcement, and space upkeep, and receives a share of charging revenue.
- Over the life of the contract, EVerged will support DEN with strategy regarding where to deploy charging as well as managing the actual installation, operation, and maintenance of a best-in-class EV charging network at DEN.

This work will support our Vision 100 pillars of:

- ❑ **Growing our Infrastructure:** This contract will dramatically increase the amount of chargers for the public and our employees, supporting EV adoption in our region and strengthening our claim as one of the most sustainable airports in the world.
- ❑ **Maintaining What We Have:** This contract will allow for the replacement of outdated existing chargers. Additionally, operation and maintenance of the charging network is included. Once they are installed, our vendor will be diligent in their upkeep of these stations for our traveling public and employee users.
- ❑ **Empowering our People:** We have identified various areas for increasing employee charging options. This will support current and future employee EV owners.

  - DEN Sustainability staff attended multiple "Taking Flight" Outreach events in addition to typical outreach of Request for Proposals
    - Engaged with dozens of potential bidders
- MWBE Goal: 15% Goal Committed to by EVerged
- Vendor selected through competitive procurement process.
  - 7 Proposals received
