At the behest of former President Clinton, Mr. Marchman also served as the Interim Executive Director of the Chicago Housing Authority. Prior to joining the Clinton administration, Mr. Marchman served as the Executive Director of the Denver Housing Authority, Deputy Chief of Staff to Mayor Federico Pena and Deputy Executive Director of CHFA. Mr. Marchman has been Director of Colorado Housing and Finance Authority, Inc., since February 2008.
