7 **Approving the appointment of Sandra Sharp to the Denver County Cultural**  
8 **Council.**

10 **WHEREAS**, Colorado Revised Statute 32-13-103(3) provides for the appointment of a  
11 county cultural council by the Denver City Council to provide for the distribution of Tier III revenues  
12 as required by the Denver Metropolitan Scientific and Cultural Facilities District; and

13 **WHEREAS**, the eleven-member Denver County Cultural Council has been established by  
14 the City Council to institute procedures for the application and determination of the distribution of  
15 Tier III funding; and

16 **WHEREAS**, the ordinance establishing the Denver County Cultural Council requires the  
17 appointment of eight members by the City Council for staggered terms of two, three, and four years  
18 and three members representing Denver Arts & Venues, Visit Denver, and Denver Public Schools,  
19 each for two-year terms.

21 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

22 **SECTION 1.** That the Council hereby appoints Sandra Sharp to the Denver County Cultural Council  
23 for a term effective immediately and ending October 1, 2022.

24 **SECTION 2.** That the Clerk of the City and County of Denver shall attest and affix the seal of the  
25 City and County of Denver to this resolution and that copies hereof be transmitted to the Denver County  
26 Cultural Council.
