5 **To set a public hearing relating to the approval of an amendment to the 9th and**

14 **Section 1.** Date, Time and Location of the 9th and Colorado Urban Redevelopment Plan
15 Amendment Public Hearing. The City Council shall conduct a public hearing on the amendment to
16 the 9th and Colorado Urban Redevelopment Plan including the creation of the 9th Avenue Project
17 and the creation of the 9th Avenue Tax Increment Area. The public hearing shall be on Monday,
18 December 8, 2014, at 5:30 p.m. in Council Chambers in the City and County Building located at
19 1437 Bannock Street, in Denver, Colorado.

20 **Section 2.** Other Notices. The Denver Urban Renewal Authority is requested to give all
21 written notices and publications required by C.R.S. § 31-25-107.

22 **Section 3.** Plan Amendment Submittal. That the 9th and Colorado Urban Redevelopment
23 Plan amendment filed with the Denver City Clerk in City Clerk's Filing No. _2014-0910 on October
24 30, 2014, be submitted to the City Council and Board of Equalization of the City, sitting as the
25 Board of County Commissioners in accordance with the Charter of the City.

26 **Section 4.** That the Clerk of the City and County of Denver shall attest and affix the seal
27 of the City and County of Denver to this Resolution.
