23	described as follows shall be and hereby is changed from I-MX-3, UO-2 to G-MS-5:			
24 25	The South 120' of the West 125', and the West 43' of the East 93' of Lot 10 in W.H. CLARK'S SECOND SUBDIVISION, City and County of Denver, State of Colorado.			
26 27	As known by Street and number as: 4964 N. Pearl St, and 624 E. 50th Ave. Denver, Colorado 80216			
28	in addition thereto, those portions of all abutting public rights-of-way, but only to the centerline			
29	thereof, which are immediately adjacent to the aforesaid specifically described area.
