A RESOLUTION

5 **Approving and providing for the execution of a proposed Grant Agreement**
6 **between the City and County of Denver and the U.S. Department of Housing**
7 **and Urban Development concerning the “Housing Opportunities for People**
8 **with AIDS (HOPWA)” program and the funding therefor.**

10 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
11 Grant Agreement;

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
14 **OF DENVER:**

15 **Section 1.** The proposed Grant Agreement, under Assistance Listing No. 14.241, between
16 the City and County of Denver and the U.S. Department of Housing and Urban Development, for the
17 “Housing Opportunities for People with AIDS (HOPWA)” program, which is identified as Grant
18 Number COH25F001, a copy of which is duly filed with the City Clerk, Filing No. 202683328, be and
19 hereby is approved in all respects.

20 **Section 2.** The payments made by the U.S. Department of Housing and Urban Development
21 to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the
22 City and credited to Special Revenue Fund No. 16000, which is set forth and described in Section
23 20-18 of the Revised Municipal Code of the City and County of Denver.

24 **Section 3.** That it be and is hereby found and determined that the budget summary of said
25 program, to be expended by the Executive Director of the Department of Housing Stability, is as
26 follows:

30 activities to prevent homelessness, including appropriate supportive services and resource
31 identification for people confirmed with AIDS or HIV.

2 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized
3 and directed to make such book and record entries and to do such other things as may be necessary
4 to accomplish the purposes of this Resolution.
