Euna Solutions, Inc. will support the Budget Professional and Payments software applications, this includes vendor monitoring of the application as well as issue resolution assistance to ensure the application is functioning at its maximum performance. This contract will pull together two separate (pre-purchased and pre-existing) technology solutions, Citybase and Questica, into one co-termed contract.

This is necessary because Citybase and Questica have both been acquired by Euna Solutions and both solutions are up for renewal. This new contract will facilitate the re-branded platform names, be written under Euna Solution as opposed to the now acquired companies and allow for both products to exist under one contract.

Euna Payments (formerly Citybase) was purchased via the Request for Proposal (RFP) process in 2020. Questica was also purchased via the RFP process back in 2014. Euna Budget (formerly Questica) was acquired by Euna Solutions in 2019.
