Aramark Sports and Entertainment Services, LLC provides customer-oriented facility services for Denver Arts & Venues facilities including Red Rocks Amphitheatre and Visitor Center, the Denver Coliseum, and the Denver Performing Arts Complex. Facility services include housekeeping services before, during, and after events, on-going non-event housekeeping services, security services, minor repair and maintenance services, and other similar facility-related services. This amendatory agreement extends the existing contract term for one additional two (2) year period per the language in Section 4 of the current agreement that allows for one additional (2) year period via written amendment.

Due to the increased business volume at Denver Arts & Venues facilities it is necessary to add additional funds to the contract.
