7 **A BILL**

8 **For an ordinance amending Chapter 22 of the Revised Municipal Code to establish**
9 **vacation rate accruals for firefighters with twenty-five (25) years or more experience, and**
10 **City contributions for Fire Commanders' Post Employment Health Plan.**

11 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

13 Section 1. That effective January 1, 2019, Chapter 22, Article II, Division 3, Section 22-
14 38.1(a) of the Revised Municipal Code is hereby amended to read as follows:

17 Sec. 22-38.1. Vacation Leave.

18
19 (a) Effective January 1, 2003, each chief, deputy chief, or division chief of the fire
20 department shall accrue vacation leave at his/her regular rate of pay in accordance with
21 the following:

22 (1) The chief, deputy chief, or division chiefs who have fewer than ten (10) years of
23 service shall accrue one hundred forty-four (144) hours vacation annually at the rate of
24 twelve (12) hours per month.

25
26 (2) The chief, deputy chief, or division chiefs who have ten (10) or more years of service
27 shall accrue one hundred sixty-eight (168) hours of vacation leave annually at the rate
28 of fourteen (14) hours per month.

29
30 (3) The chief, deputy chief, or division chiefs who have fifteen (15) or more years of
31 service shall accrue one hundred ninety-two (192) hours of vacation leave annually at
32 the rate of sixteen (16) hours per month.

33
34 **(4) Effective January 1, 2020, the chief, deputy chief, or division chiefs who have**
35 **twenty-five (25) or more years of service shall accrue two hundred sixteen (216)**
36 **hours of vacation leave annually at the rate of eighteen (18) hours per month.**

38 Section 2. That effective January 1, 2019, Chapter 22, Article II, Division 3, Section 22-
39 39(9) of the Revised Municipal Code is hereby amended to read as follows:

41 (9) City contribution to the Fire Commanders' Post Employment Health Plan as
42 follows: ~~one-half of one percent (.5%) of base pay per year for 2013 and 2014; one~~ **and**
43 **one-quarter** percent (1.0**25**%) of base pay per year for ~~2015~~ **2019** and thereafter.
