**A BILL**

**For an ordinance making appropriations from the State Conservation Trust Fund for the purchase of land from Xcel Energy.**

**WHEREAS**, funding will support the purchase of two parcels of land from Xcel Energy for Parks and Recreation open space;

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the State Conservation Trust Fund, Accounting No. 35000, out of monies not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 699, Series of 2014, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following each such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
