16 City and County of Denver, a copy of which is duly filed with the City Clerk, Filing No. 17-0053, be
17 and hereby is approved in all respects.

18 **Section 2.** The payments made by the Great Outdoors Colorado (GOCO) to the City
19 pursuant to and under the contract shall be deposited into the Treasury of the City and credited to
20 Special Fund No. 38000, which is set forth and described in Section 20-18 of the Revised
21 Municipal Code of the City and County of Denver.
