9 For an ordinance approving and providing for the execution of a proposed grant
10 agreement between the City and County of Denver and the State of Colorado
11 concerning the "FY2011 Crime Victim Services" program and the funding therefor.

13 WHEREAS, the City and County of Denver has given due consideration to said proposed
14 Grant Agreement;

15 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY
16 OF DENVER:

17 Section 1. The proposed Grant Agreement, under CFDA No. 16.588, between the State of
18 Colorado Division of Criminal Justice and the City and County of Denver, which is identified as
19 Grant Number 29-VW-2-41, a copy of which is duly filed with the City Clerk, Filing No. 10-1164,
20 be and hereby is approved in all respects.

21 Section 2. The Mayor or his lawful successor and other proper officials of the City and
22 County of Denver, in its behalf, are hereby authorized and directed to execute said Grant
23 Agreement and the Clerk and Recorder of the City and County of Denver is hereby authorized
24 and directed to attest and impress the official seal of the City and County of Denver on the Grant
25 Agreement.

26 Section 3. The Mayor, his successor in office, or his duly authorized representatives, and
27 other officials of the City are hereby authorized and directed to do all things required to be done
28 in order to obtain payments under the Grant Agreement, including, but not limited to, filing
29 requests for payments, contracting with persons and organizations in order to carry out the
30 provisions of the Grant Agreement, filing reports and keeping records relating to fiscal and
31 evaluation matters, and forwarding other materials to the State of Colorado.

32 Section 4. The payments made by the State of Colorado to the City pursuant to and under
33 the Grant Agreement shall be deposited into the Treasury of the City and credited to Special
34 Fund No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal
35 Code of the City and County of Denver.

1 Section 5. That it be and is hereby found and determined that the budget summary of said
2 "FY2011 Crime Victim Services" Program, Accounting Number 12220-3518101-S2122, is as
3 follows, to be expended by the Manager of Safety.

4 State of Colorado \$143,569.00

5 A cash match in the amount of \$20,835.00 is required by the Grant and will be provided by
6 the Victim Assistance Special Revenue Fund, Accounting No. 12813-3513000. An in-kind
7 match in the amount of \$27,022.00 is required by this Grant and will be met by personnel hours
8 in the Victim Assistance Unit.

9 Authorization for expenditure of said funds following execution of said grant will cover the
10 period from January 1, 2011 to December 31, 2011.

11 Section 6. The Manager of Finance of the City and County of Denver is hereby authorized
12 and directed to make such book and record entries and to do such other things as may be
13 necessary to accomplish the purposes of this Ordinance.
