7 **A BILL**

8 **For an ordinance amending Ordinance 915, Series of 2025, concerning the “Denver**
9 **Downtown Development Authority” Fund (11893).**

10 **WHEREAS**, the “Denver Downtown Development Authority” Fund (11893) was established via
11 Ordinance 915, series of 2025; and

12 **WHEREAS**, the Department of Finance wishes to amend the fund type from appropriated to
13 revenue-based; and

14 **WHEREAS**, this request is a companion to the annual Long Bill and allows for an administrative
15 action needed to implement the 2026 budget as adopted;

16 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
17 **DENVER:**

18 **Section 1.** That Section 3 of Ordinance 915, Series of 2025, is hereby amended as follows:

19 **“Section 3.** Expenditures are hereby authorized for the
20 “Denver Downtown Development Authority” Special Revenue
21 Fund, Accounting No. 11893, to be expended by the Chief
22 Financial Officer. Authorized expenditures for Accounting No.
23 11893 include operational and administrative expenses in
24 accordance with C.R.S. §§ 31-25-801, et seq., the Amended and
25 Restated Plan of Development for the DDDA, and the Cooperation
26 Agreement. This is an revenue-basedappropriated, non-lapsing
27 fund. This fund will retain interest earnings.”


28 **Section 2.** The Chief Financial Officer of the City and County of Denver is hereby authorized

30 to accomplish the purposes of this Ordinance.
