CB10-0981 A bill for an ordinance approving a proposed First Amendatory Agreement between the City and County of Denver and Live Nation Worldwide, Inc. ("Live Nation"), to provide Live Nation with an incentive to promote and book concerts and live events at the City's venues. (BUSINESS, WORKFORCE, & SUSTAINABILITY)

Amends the Live Nation Worldwide, Inc. contract to extend the agreement two years through December 31, 2012 and to add \$1.2 million to promote and book live concerts and events at Denver Performing Arts Complex venues, Denver Coliseum, and Red Rocks Amphitheatre. The last regularly scheduled Council meeting within the 30-day review period is on 12-13-10. The Committee approved filing this bill by consent on 11-11-10.

CB10-0982 A bill for an ordinance approving a proposed First Amendatory Agreement between the City and County of Denver and AEG Live – Rocky Mountains, LLC ("AEG Live"), to provide AEG Live with an incentive to promote and book concerts and live events at the City's venues. (BUSINESS, WORKFORCE & SUSTAINABILITY)

Amends the contract with AEG Live- Rocky Mountain, LLC to add two years to the agreement through December 31, 2012 and to add \$1.2 million to attract promoters to host events at Denver Performing Arts Complex venues, Denver Coliseum, and Red Rocks Ampitheatre. The last regularly scheduled Council meeting within the 30-day review period is on 12-13-10. The Committee approved filing this bill by consent on 11-11-10.

CB10-1011 A bill for an ordinance approving an Operating Plan and Budget for 2011 for the Colfax Business Improvement District. (BUSINESS, WORKFORCE, & SUSTAINABILITY)

Approves the 2011 Operating Plan and Budget (\$419,300) for the Colfax Business Improvement District in Council Districts 8 and 10. The Committee approved filing this bill by consent on 11-11-10.

CB10-0987 A bill for an ordinance amending Ordinance 504, Series of 2010 concerning the "Emergency Management Performance FY09" grant and the "Emergency Management Project Fund." (GOVERNMENT AFFAIRS & FINANCE)

Amends Ordinance 504, series 2010 to correct amount of budget rescinded and cash transferred related to Emergency Management fund accounts. The Committee approved filing this bill by consent on 11-11-10.

CB10-0995 A bill for an ordinance approving an amendatory agreement between CorVel Corporation and the City & County of Denver to extend term for fee scheduling, bill review of medical provider billings and reviewing information via electronic transfer. (GOVERNMENT AFFAIRS & FINANCE)

Approves an amendment to the CorVel Corporation contract to extend the contract through December 31, 2011 and to add \$700,000 for bill review and repricing services for the City's Workers' Compensation Program. The last regularly scheduled Council meeting within the 30-day review period is on 12-13-10. The Committee approved filing this bill by consent on 11-11-10.

CB10-0996 A bill for an ordinance approving a third amendatory agreement between IMED, LLC and the City and County of Denver to increase funding for pharmacy management and program benefits. (GOVERNMENT AFFAIRS & FINANCE)

Approves amending the contract with IMED, LLC to add one year through December 31, 2011 and to add \$600,000 to provide pharmacy benefit management services for the City and County of Denver's Workers' Compensation Program. The last regularly scheduled Council meeting within the 30-day review period is on 12-13-10. The Committee approved filing this bill by consent on 11-11-10.

CB10-0997 A bill for an ordinance approving an amendatory agreement between Occupational Health Centers of Southwest, PA d/b/a Concentra Health Services and the City and County of Denver to extend term of agreement to provide alternative choice to City and County of Denver employees for occupational medical services. (GOVERNMENT AFFAIRS & FINANCE)

Approves amending the contract with Occupational Health Centers of the Southwest, P.A. d.b.a Concentra Health Services to extend the contract through December 31, 2011 and to add \$340,000 for occupational health services for the City of Denver's Workers' Compensation Program. Approves a Master Purchase Order of about \$1 million with Front Range Wholesale from September 20, 2010 to February 28, 2011 to provide groceries for the Sheriff Department Kitchen and Human Services Family Crises Center. The last regularly scheduled Council meeting within the 30-day period is on 12-13-10. The Committee approved filing this bill by consent on 10-11-10.

CB10-0975 A bill for an ordinance approving an agreement between Denver Inner City Parish and the City & County of Denver to operate the College View Recreation Center and administer programs to the community. (HEALTH, SAFETY, EDUCATION & SERVICES)

Approves a contract with Denver Inner City Parish to administer community programs at College View Recreation Center. The last regularly scheduled meeting within the 30-day period is on 12-13-10. The Committee approved filing this bill at its meeting on 10-9-10.

CB10-0976 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the State of Colorado concerning the "FY2011 Crime Victim Services" program and the funding therefor. (HEALTH, SAFETY, EDUCATION & SERVICES)

Accepts \$143,569 from the state for the FY2011 Crime Victim Services grant to sustain the Domestic Violence Night Shift Team with a cash match of \$20,825 provided from the City's Victim Assistance Unit funds. CB10-0978 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Main Street Power Company, Inc., to lease space on Rude Recreation Center at 2855 West Holden Place. (HEALTH, SAFETY, EDUCATION & SERVICES)

Amends the existing solar lease agreement with Main Street Power Company so that the contractor can cover the existing roof warranty at Rude Recreation Center. The last regularly-scheduled Council meeting within the 30-day period is on 12-13-10. The Committee approved filing this bill by consent on 10-11-10.

CB10-0999 A bill for an ordinance accepting funding from the United States of America for the "State Criminal Alien Assistance Programs (SCAAP)" for Fiscal Year 2010 and authorizing expenditures therefor. (HEALTH, SAFETY, EDUCATION & SERVICES)

Accepts \$769,680 from the US Department of Justice for the State Criminal Alien Assistance Program (SCAAP) award to partially refund correctional facilities for housing foreign born inmates who are convicted of a felony or two or more misdemeanors. Grants a utility easement to Forest City in conjunction with the City's land acquisition for the new Stapleton Library, a Better Denver Bond project in Council District 11. The Committee approved filing this bill by consent on 10-7-10.

CB10-1002 A bill for an ordinance amending Article XI of Chapter 24, Denver Revised Municipal Code, concerning the licensing of medical marijuana dispensaries in order to provide a procedure for modification of the licensed premises (SPECIAL ISSUES)

Creates a procedure for modifying premises in licensed medical marijuana dispensaries. The Committee approved filing this bill at its meeting on 11-8-10.

Any protests against CB10-1009 must be filed in the Council Office no later than Monday, December 27, 2010.
