A BILL

For an ordinance making a rescission from and an appropriation in the Capital Improvements and Capital Maintenance Fund.

WHEREAS, in 2016, \$1 million was appropriated in the Capital Improvement Program, under the expending authority of the Office of Economic Development, currently Denver Economic Development and Opportunity (DEDO), to support a required match for the Economic Development Administration (EDA) grant to complete construction of parking infrastructure along the Welton Corridor to support local economic activity; and

WHEREAS, the City was not successful with the EDA grant opportunity and the infrastructure and economic development needs in the area have changed over the past 5 years,

WHEREAS, this ordinance re-appropriates the \$1 million within the Capital Improvement Program to remain under DEDO's expending authority, maintaining the original intent for capital infrastructure to support economic development; and

WHEREAS, the funds will be used for various infrastructure improvements in the northeast downtown neighborhoods to continue to support business activity and the local economy, in alignment with the original intent;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the Capital Improvements and Capital Maintenance Fund there is hereby RESCINDED the amount listed or indicated in the following tabulation under the heading "Amount Rescinded" and transferred to the Capital Improvements and Capital Maintenance Fund:
