In 2019, the City and County of Denver issued a RFP to provide professional services to assist in the planning, development, operation, and execution of Denver Smart City projects. This included technology development and deployment, data analysis, and strategic development and planning that focused on sustainability, mobility, access, resilience, and transparency.

Due to the success of the Denver Smart City program and term limits of the previous on-call contracts, the Department of Transportation and Infrastructure issued a RFQ (202476214) seeking consultants that specialize in Advanced Mobility initiatives. The RFQ was soliciting on-call services for staff augmentation to support traffic engineering/operations and Advanced Mobility programs.

This on-call contract with HIRE POWER, INC dba INNOVAR GROUP is one of three that will provide staff augmentation for System Operations Administrative Services to support traffic engineering/operations and Advanced Mobility/ITS/Connected Vehicle infrastructure, software development, network environment, and Geographical Information System.
