ABILL

FOR AN ORDINANCE LAYING OUT, OPENING AND ESTABLISHING PORTIONS OF REAL PROPERTY AND CERTAIN HIGHWAY GRADE SEPARATION STRUCTURES AS A PUBLIC STREET TO BE KNOWN AND DESIGNATED AS VALLEY HIGHWAY.

WHEREAS, the Manager of Public Works of the City and County of Denver has found and determined that the public use, convenience and necessity require the laying out, opening and establishing as a public street to be designated as Valley Highway those portions of real property and highway grade separation structures hereinafter more particularly described and, subject to approval by ordinance, has laid out, opened and established the same as a public street;

NOW, THEREFORE,

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the action of the Manager of Public Works in laying out, opening and establishing as a public street the following described real property and highway grade separation structures, situate, lying and being in the City and County of Denver, State of Colorado, to-wit:


