**A BILL**

**For an ordinance authorizing expenditures the Denver Health and Hospital Authority Tax Fund (11892) based on projected sales tax revenue for 2025.**

**WHEREAS**, the November 2024 election, Denver voters approved ballot issue 2Q, authorizing a 0.34 percent sales and use tax to support Denver Health and Hospital Authority (DHHA); and

**WHEREAS**, Ordinance 1840, Series of 2025 created the “Denver Health and Hospital Authority Tax Fund” Special Revenue Fund, Fund No. 11892 in the General Government Special Revenue Fund Series, to receive the tax revenue from the increase in sales and use tax; and

**WHEREAS**, City and County of Denver wishes to appropriate budget based on projected dedicated sales and use tax revenue for 2025; and

**WHEREAS**, this request is a companion to Ordinance 0226, series of 2025, to approve the contract between the City and DHHA;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** Expenditures are hereby authorized from the General Government Special Revenue Fund, Accounting No. 11000, the amount of money in the following tabulation to be expended for the purposes and upon the authorizations in said Ordinance set forth:
