CONTRACT DESCRIPTION

- Contract Description:
 - Current contract: AECOM Technical Services, Inc., 5 years, \$20 Million
 - Contract amendment: Request for an additional \$5 Million
 - Scope: Provide professional, technical and support staff to perform or assist with quality assurance (QA) support services
- What is the benefit to DEN
 - Continued staffing and professional services for this contract will provide continuity in project delivery until contract is complete
 - A short duration contract would make it difficult for the consultant to secure and retain the highly qualified personnel required
- Selected Firm: AECOM Technical Services, Inc.



SELECTION PROCESS

- Describe the selection process
 - An RFP selection process was used for the original contract
 - The selection panel consisted of representatives from Airport Infrastructure Management, Public Works, the airlines, and the M/WBE community
- Previous incumbent: AECOM Technical Services, Inc.
- Selection criteria: This was a qualifications based selection
- Local company: Yes. This is an international company with a local office base
- How many employees does this company employ: 95,000

CONTRACT TERMS AND AMOUNT

• Contract Term: Five (5) Years

Contract Amount:

Current: \$20 Million

• Amendment: \$5 Million

• Justification for additional budget:

- The additional budget requested will carry this contract until the contract is complete.
- The support services provided by this contract are critical to the operation of DEN and the completion of CIP and O&M projects in a timely manner.
- A short duration contract would make it difficult for the consultant to secure and retain the highly qualified personnel required



BUSINESS CASE SUMMARY

- The current AECOM Technical Services, Inc. contract provides personnel to deliver CIP and O&M contracts
- Typically these personnel are brought in for multiple projects and have remained at DEN for multiple years
- Substantial time, investment, effort and risk are involved in the training and orientation of new personnel
- A short duration contract would make it difficult for the consultant to secure and retain the highly qualified personnel required
- A turnover of personnel for a short contract will likely require paying premium labor rates and could result in inefficiencies and a higher potential of mistakes that could impact operations, safety, and/or quality of work
