11 **located at the intersection of East 27th Avenue and North Lima Street; and 6)**
12 **East 26th Avenue, located at the intersection of East 26th Avenue and North**
13 **Kingston Street.**

15 the City and County of Denver has found and determined that the public use, convenience and
