15 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

16 **Section 1.** That the Council of the City and County of Denver hereby approves and  
17 authorizes the expenditure and payment from the 2019 appropriation account designated as  
18 “Liability Claims” (Accounting Number 11827-4511001), the sum of One Million Five-Hundred Fifty-  
19 Thousand and 10/100 Dollars (\$1,550,000.10), of which \$609,268.80 will be paid to the Jester  
20 Gibson & Moore LLP Trust Account, and \$940,731.30 will be paid to the individual plaintiffs for wages  
21 and compensatory damages, in payment and satisfaction of all claims filed by the 15 plaintiffs in the  
22 lawsuit against the City in the United States District Court, District of Colorado, Case No. 15-cv-  
23 02539-CMA-STV.
