8 **For an ordinance establishing a new Capital Fund in the Grant and Other Money
9 Projects Fund Series for the “High Line Canal/Yale Avenue Improvements Fund”
10 and authorizing appropriations in the new fund.**

13 **WHEREAS**, Ordinance No. 644, Series of 2022, approves execution of a cost sharing
14 agreement with Arapahoe County for the Highline Canal Trail and Roadway improvement project
15 at Yale Ave.; and

16 **WHEREAS**, per the agreement Arapahoe County will pay the City and County of Denver for
17 project Design costs for the Highline Canal Trail and Roadway improvement project at Yale Ave;
18 and

19 **WHEREAS**, the Department of Finance (DOF) requires the creation of new Capital
20 Improvement Fund under the Grant and Other Money Project Fund Series, Accounting No. 38000,
21 for revenue and expenditures related to improvements to Yale Avenue and the High Line Canal Trail;

24 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF
25 DENVER:**

27 **Section 1.** A new fund is hereby established in the Grant and Other Money Projects Fund
28 Series, Accounting No. 38000, the “High Line Canal/Yale Avenue Improvements Fund,” Accounting
29 No. 38433, for the purpose of accounting for improvements to Yale Avenue and the High Line Canal
30 Trail.

31 **Section 2.** Monies received supporting improvements on Yale Avenue and the High Line Canal
32 Trail shall be deposited into the Treasury of the City and credited to the Grant and Other Money
33 Projects Fund Accounting No. 38000, which is set forth and described in Section 20-18 of the
34 Revised Municipal Code of the City and County of Denver.

1 **Section 3.** Expenditures are hereby authorized for the "High Line Canal/Yale Avenue
2 Improvements Fund," Accounting No. 38433, to be expended by the Executive Director of the
3 Department of Transportation and Infrastructure. This Fund is appropriated and non-lapsing.

4 **Section 4.** That it be and is hereby found and determined that the budget summary of said
5 program, to be expended by the Executive Director of the Department of Transportation and
6 Infrastructure, is as follows:

9 The foregoing authorizes expenditures for the High Line Canal/Yale Avenue Improvements Project
10 per the intergovernmental agreement between the City and County of Denver and Arapahoe County.

11 **Section 5.** The Chief Financial Officer of the City and County of Denver is hereby authorized
12 and directed to make such book and record entries and to do such other things as may be
13 necessary to accomplish the purposes of this Ordinance.
