**A BILL**

**For an ordinance amending Ordinance No. 1317, Series of 2022 to change the capital budget rescission from Fund 34991 to Fund 33069 and to approve a transfer of cash between Fund 33069 to Fund 34991.**

**WHEREAS**, Ordinance No. 1317, Series of 2022, rescinded savings from completed facilities capital maintenance projects and made appropriations to support priority facility maintenance projects in the City; and

**WHEREAS**, an incorrect fund number was used in the Section 1 table, rows fourteen and fifteen; and

**WHEREAS**, this ordinance seeks to correct said Fund without making changes to the approved appropriations;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**
