4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**
6 **of land as a public alley bounded by East 13th Avenue, North Ivy Street, East**
7 **14th Avenue and North Jersey Street.**

8 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
9 found and determined that the public use, convenience and necessity require the laying out, opening
10 and establishing as a public alley designated as part of the system of thoroughfares of the
11 municipality that portion of real property hereinafter more particularly described, and, subject to
12 approval by resolution has laid out, opened and established the same as a public alley;

13 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening
15 and establishing as part of the system of thoroughfares of the municipality the following described
16 portion of real property situate, lying and being in the City and County of Denver, State of Colorado,
17 to wit:

18 **PARCEL DESCRIPTION ROW NO. 2018-DEDICATION-000028-001:**

19 A parcel of land as described in that Quit Claim Deed to the City and County of Denver, recorded
20 on the 8th day of October 1941, at Book 5533, Page 389 at the City and County of Denver Clerk
21 and Recorder’s Office, State of Colorado, therein as:

22 The Easterly Ten (10) feet of Lots numbered One (1) to Twenty (20) inclusive and the Westerly Five
23 (5) feet of Lots numbered Twenty-one (21) to Forty (40) inclusive, Block numbered One Hundred
24 Thirteen (113), COLFAX TERRACE

25 be and the same is hereby approved and said real property is hereby laid out and established and
26 declared laid out, opened and established as a public alley.

27 **Section 2.** That the real property described in Section 1 hereof shall henceforth be a public
28 alley.
