

## REVIVAL AND THIRD AMENDATORY AGREEMENT

**THIS REVIVAL AND THIRD SPECIAL COUNSEL AMENDATORY AGREEMENT** (“Agreement”) is made between the **CITY AND COUNTY OF DENVER**, a home rule and municipal corporation of the State of Colorado (“City”) and **SGR LLC**, a Colorado limited liability company, whose address is 3900 East Mexico Avenue, Suite 700, Denver, Colorado 80210 (“Special Counsel”), collectively “the Parties.”

### RECITALS:

**WHEREAS**, the Parties entered into an Agreement dated March 22, 2019, an Amendatory Agreement dated May 18, 2022, and a Second Amendatory Agreement dated May 3, 2024 to perform, and complete all of the services outlined in the Scope of Work (the “Agreement”) to the City’s satisfaction.

**WHEREAS**, the Parties wish to revive and amend the Agreement to extend the term.

**NOW THEREFORE**, in consideration of the premises and the Parties’ mutual covenants and obligations, the Parties agree as follows:

1. Paragraph **3** of the Agreement entitled “**TERM**” is hereby deleted in its entirety and replaced with:

“**3. TERM**: The term of the Agreement is from March 1, 2019, until December 31, 2025 (“Term”). Subject to the City Attorney’s prior written authorization, Special Counsel shall complete any work in progress as of the expiration date and the Term of the Agreement will extend until the work is completed or earlier terminated by the City Attorney.

2. Effective upon execution, all references to “**Exhibit A and A-2**” in the existing Agreement shall be amended to read “**Exhibit A, A-2 and A-3**” as applicable. The Scope of Work marked as **Exhibit A-3** is attached hereto and incorporated herein by this reference.

3. As herein amended, the Agreement is affirmed and ratified in each and every particular.

4. This Revival and Third Special Council Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
