SUMMARY:

The purpose of this resolution is to dedicate A strip of Syracuse St., from 23rd Ave. south for

approximately 351 feet.

This parcel of land was deeded to the City and County of Denver by a Special Warranty Deed recorded in the Office of the Denver County Clerk and Recorder on December 28, 2009, under Reception Number 2009166893 to facilitate the Stapleton Filing No. 8 development, which is located between Syracuse St. and east for approximately 620 feet and between 22nd Ave.and approximately 206 feet south of 24th Ave.

Therefore, you are requested to initiate Council action to dedicate the following as:

(1) Syracuse St., (a 6 foot strip) from 23rd Ave. south approximately 351 feet, the land in the following described area:
