4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system parcels**
6 **of land as Tamarac Street and Uinta Street, in Stapleton Filing No. 23.**

8 **WHEREAS**, the Executor Director of Public Works of the City and County of Denver has
9 found and determined that the public use, convenience and necessity require the laying out,
10 opening and establishing as public streets designated as part of the system of thoroughfares of the
11 municipality those portions of real property hereinafter more particularly described, and, subject to
12 approval by resolution has laid out, opened and established the same as public streets;

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
14 **OF DENVER:**

16 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening
17 and establishing as part of the system of thoroughfares of the municipality the following described
18 portion of real property, to wit:

19 (1) Tamarac St. from Northfield Blvd. north to south line of Stapleton Filing No. 36, the
20 land in the following described area:

21 **Tract A, Stapleton Filing No. 23, City and County of Denver, State of Colorado.**

23 be and the same is hereby approved and said real property is hereby laid out and established and
24 declared laid out, opened and established as Tamarac Street.

25 **Section 2.** That the real property described in Section 1 hereof shall henceforth be known
26 as Tamarac Street.

27 **Section 3.** That the action of the Executive Director of Public Works in laying out, opening
28 and establishing as part of the system of thoroughfares of the municipality the following described
29 portion of real property, to wit:

30 (2) Uinta St. from Northfield Blvd. north to south line of Stapleton Filing No. 36, the land in
31 the following described area:

32 **Tract B, Stapleton Filing No. 23, City and County of Denver, State of Colorado.**

34 be and the same is hereby approved and said real property is hereby laid out and established and
35 declared laid out, opened and established as Uinta Street.

1 **Section 4.** That the real property described in Section 3 hereof shall henceforth be known
2 as Uinta Street.
