


The Why

- Denver's Fair Elections Fund (FEF) has successfully bolstered transparency and accessibility in local elections since its debut in 2023. However, several candidates and officials reported confusion with the FFE process.
- After evaluating the first implementation and gathering stakeholder feedback, Councilmembers Sawyer and Watson are ready to propose essential campaign finance updates for 2025 to promote transparency.
- These changes are designed to ensure the FEF remains an effective, equitable tool that supports all candidates and deepens voter confidence in our election processes.

Proposed Changes

After gathering additional feedback from Councilmembers in the June 24th, Budget & Policy Committee session, CMs Sawyer and Watson suggest the following changes:

- Unify and simplify the election code
- Ban anonymous donations
- Equalize contribution amounts for FEF and non-FEF candidates
- Clarify requirements for neutral debates
- Update the requirements for neutral hearing officers
- List prohibited expenditures for FEF money



Unify and Simplify the Election Code

The Problem

- Denver's current campaign finance regulations, Chapter 15, Article III, are scattered, confusing, and cumbersome.
- The disorganization and complexity of Article III make it difficult for candidates to understand, navigate, and ensure proper campaign compliance.

The Solution: One Simple and Unified Campaign Finance Code

 At the Clerk & Recorder's request, this is not a repeal and replace but significant organizational changes have been made to improve readability and accessibility.



Ban Anonymous Donations

The Problem

- Anonymous contributions can obscure the hidden influencers in our elections, eroding trust in Denver's democracy.
- Cash contributions obstruct the disclosure requirement necessary for transparent and fair elections.

The Solution: Ban All Anonymous Donations

- To increase transparency and trust, the ordinance proposes a complete ban on anonymous contributions, including "fishbowl" contributions.
- Several other Colorado municipalities have already banned anonymous contributions.



Equalizing Max Contributions

The Problem

- Currently, FEF candidates can raise more money per donor than a non FEF candidate, creating an unequal playing field.
- Possible solutions are either increasing the max contribution per person for non FEF participants or reducing the FEF match amount to meet the non FEF limit.

Considerations:

- Increasing the non FEF participant limit allows for larger donations.
- Decreasing the FEF match amount significantly reduces the amount of money candidates have on hand to conduct voter outreach.



Equalize Max Contributions – 2023 Non-Adjusted

- Decrease Non-Participant Mayoral Limit by \$50
- Increase Non-Participant Auditor, Judge, C&R, & Councilmember A-L Limit by \$100
- Increases Non-Participant District Councilmember Limit by \$250

Non-Participant

Equalize Max Contributions – Adjusted to 2024 Inflation

- Adjusted for inflation every 4 years by establishing the updated Non-Participant max
- Takes the Non-Participant max and reduces by \$450 to establish the updated FEF Participant max
- These numbers are adjusted by 1.19% Consumer Price Index increase the Clerk's Office calculated in Q1 of 2024

Neutral Debates

The ordinance will strengthen and clarify the rules for mandatory debates to ensure a fair and level playing field for all candidates.

- Only required if more than one FEF candidate in a race
- One required for the general and run off
- Ensure debate moderators and hosts are not affiliated with any candidate in the race
- ADA requirements



Administrative Hearing Officers

The ordinance will strengthen and clarify the role of neutral hearing officers and proposes the following:

- Mandating the use of neutral administrative hearing officers to review FEF and other campaign finance complaints.
- Prohibiting hearing officers from being full-time employees of the Clerk & Recorder.
- Authorizing hearing officers to issue subpoenas.
- May assess penalty for violations of use of city funds.



Spending Restrictions & Prohibited Expenditures

- Any salary or payment to an individual unless that individual is providing bona fide services to the campaign and is compensated at fair market value;
- Admission to a sporting event, concert, theater or other form of entertainment unless part of a specific campaign activity;
- Dues, fees, parking or gratuities at a country club, health club or other recreational facility unless the costs are part of a specific fundraising event;
- Mortgage, rent or household utility payments for any part of a personal residence;

- Purchases of personal household food items, supplies or services;
- Purchase of clothing, other than items of de minimus value used in the campaign;
- Repayment of any loans, debts or penalties;
- Out-of-state travel;
- The purchase of "alcoholic beverages" as that term is defined at Chapter 6;
- The purchase of "regulated marijuana" as that term is defined in the Colorado Marijuana Code;
- The purchase of "tobacco products" as that term is defined in Chapter 24;



Spending Restrictions & Prohibited Expenditures Cont.

- Payment to a registered voter in exchange for that voter agreeing to vote in an election.
- Automobile purchase or leases;
- Computer hardware or software valued at more than \$250 less than two weeks prior to the election;
- Gifts valued more than fifty dollars (\$50.00)
- Fundraising percentage fees to be no more than 5% of total fair election fund distributions;
- Legal fees, other than fees for bona fide services to the campaign and compensated at fair market value;
- Payments of fees or fines to the City and County of Denver;

- Payments for campaign services past 45 days post election;
- Tuition payments;
- Used to purchase any prepaid credit or gift cards of any kind;
- Funds used to promote business interests of candidate or immediate family members of the candidate;
- Staff appreciation events with a combined total of over \$500;
- Reimbursing contributors for their contributions;
