FOR AN ORDINANCE VACATING A PORTION OF THE ALLEY IN BLOCK 1, LAWRENCE'S BROAD-WAY ADDITION, SUBJECT TO RESERVATIONS.

WHEREAS, the Manager of Public Works of the City and County of Denver has found and determined that the public use, convenience and necessity no longer require that portion of a certain alley hereinafter described, and, subject to approval by ordinance, has vacated the same with the reservations hereinafter set forth; NOW, THEREFORE,

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the action of the Manager of Public Works in vacating the following described portion of an alley in the City and County of Denver, State of Colorado, to-wit:

The North 100' of the South 200' of the alley in Block 1, Lawrence's Broadway Addition;

reserving (1) to the City and County of Denver at all times an easement and right of way for, and the right to construct, operate, maintain, and remove sewers, water pipes, and appurtenances and to authorize the construction, operation, maintenance, and removal of sewers, water pipes, and appurtenances therein and therefrom, and (2) to the utility owners the continued use of and the right to maintain and operate existing electric light and power lines and, be and the same is hereby approved and said portion of said alley is hereby vacated and declared vacated subject to the reservations above set forth.

Section 2. The Council finds this ordinance is necessary for the immediate preservation of the public health and public safety and determines that it shall take effect immediately upon its final passage and publication.
