A BILL

For an ordinance making a rescission from and an appropriation in the General Fund.

WHEREAS, Denver’s council districts must undergo redistricting every ten years after the completion of the census; and

WHEREAS, City Council requires additional budget for community outreach as well as software costs to support the redistricting effort;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
