8 **for an ordinance amending Chapter 18 of the Revised Municipal Code**  
9 **establishing salaries and benefits for command staff in the Denver Sheriff**  
10 **Department for 2023 in accordance with the amended collective bargaining**  
11 **agreement.**

13 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

15 **Section 1.** That effective January 1, 2023, Chapter 18, Article IV, Section 18-101, D.R.M.C.,  
16 shall be amended by deleting the language stricken and adding the language underlined, to read as  
17 follows:

19 Sec. 18-101. – Deputy sheriff major, deputy sheriff division chief, and sheriff pay plans.

21 (a) Effective January 1, 2022, the annual salary for deputy sheriff majors, deputy sheriff  
22 division chiefs and the sheriff shall be as follows:

24 Deputy sheriff major: \$157,064.00  
25 Deputy sheriff division chief: \$194,760.00  
26 Sheriff: \$209,334.00

28 (b) Effective January 1, 2023, the annual salary for deputy sheriff majors, deputy sheriff  
29 division chiefs and the sheriff shall be as follows:

31 Deputy sheriff major: ~~\$161,776.00~~ **\$163,347.00**  
32 Deputy sheriff division chief: ~~\$200,603.00~~ **\$202,550.00**  
33 Sheriff: ~~\$215,614.00~~ **\$217,707.00**

35 (c) Effective July 1, 2023, the annual salary for deputy sheriff majors, deputy sheriff  
36 division chiefs and the sheriff shall be as follows:

38 Deputy sheriff major: ~~\$163,394.00~~ **\$164,980.00**  
39 Deputy sheriff division chief: ~~\$202,609.00~~ **\$204,576.00**  
40 Sheriff: ~~\$217,770.00~~ **\$219,884.00**
