8 **For an ordinance approving and providing for the execution of a proposed**  
9 **Intergovernmental Agreement between the City and County of Denver and the**  
10 **State of Colorado, Department of Transportation, concerning the "Federal**  
11 **Highway Safety Improvement Program (HSIP) 2018 Package 3 City and County**  
12 **of Denver Traffic Signal Replacement" project and the funding therefor.**

15 **WHEREAS**, the City and County of Denver has given due consideration to said proposed  
16 Intergovernmental Agreement; and

17 **WHEREAS**, the traffic signal improvements will be located at 7<sup>th</sup> Avenue and Josephine Street  
18 and 7<sup>th</sup> Avenue and York Street;

19 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
20 **DENVER:**

21 **Section 1.** The proposed Intergovernmental Agreement, under CFDA No. 20.205, between  
22 the State of Colorado, Department of Transportation, and the City and County of Denver, a copy of  
23 which is duly filed with the City Clerk, Filing No. 17-0555, be and hereby is approved in all  
24 respects.

25 **Section 2.** The payments made by the Colorado Department of Transportation to the City  
26 pursuant to and under the Intergovernmental Agreement shall be deposited into the Treasury of  
27 the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18  
28 of the Revised Municipal Code of the City and County of Denver.

1       **Section 3.** That it be and is hereby found and determined that the budget summary of said
