The agreement is between SOUTHEAST PUBLIC IMPROVEMENT METROPOLITAN DISTRICT, (“SPIMD”); the REGIONAL TRANSPORTATION DISTRICT, (“RTD”); MADRE METROPOLITAN DISTRICT NO. 1, GOLDSMITH METROPOLITAN DISTRICT and THE CITY AND COUNTY OF DENVER. The City’s contribution is \$700K toward a total estimated project cost of \$7.6M
