10 **For an ordinance approving and providing for the execution of a proposed**
11 **grant agreement between the City and County of Denver and the United**
12 **States Department of Health and Human Services concerning the "Head Start**
13 **FY13-14" program and the funding therefor.**

16 **WHEREAS**, Ordinance No. 321, Series of 2013, authorized expenditures equal to half of the
17 amount indicated in a letter of intent from the United States Department of Health and Human
18 Services to fund the "Head Start FY13-14" program; and

19 **WHEREAS**, the United States of America has tendered to the City a Grant award for said
20 program; and

21 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
22 Grant Agreement;

24 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
25 **OF DENVER:**

27 **Section 1.** The proposed Grant Agreement, under CFDA No. 93.600, between the United
28 States of America and the City and County of Denver, which is identified as Grant Number
29 08CH1119/01, a copy of which is duly filed with the City Clerk, Filing No. 13-1000, be and hereby
30 is approved in all respects.

31 **Section 2.** The payments made by the United States of America to the City pursuant to and
32 under the Grant Agreement shall be deposited into the Treasury of the City and credited to
33 Special Fund No. 11000, which is set forth and described in Section 20-18 of the Revised
34 Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said "Head Start FY13-14" Program, Accounting No. 11002-0104101-M1097 is as follows, to be expended by the Director of the Mayor's Office for Education and Children:

Authorized by previous ordinance	\$4,182,673
Authorized by this ordinance	<u>4,182,673</u>
Federal Government	\$8,365,346

The foregoing authorization will provide services (education, nutrition, health, mental health, disabilities and family services) to 1,153 eligible children ages 3-5. Authorization for expenditure of said funds following execution of said grant will cover the period from July 1, 2013 to June 30, 2014.

Section 4. The Manager of Finance of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
