A BILL

For an ordinance making an appropriation in the Colorado Convention Center Capital Fund.

WHEREAS, the City and County of Denver, 2023 Mayor’s Budget included an appropriation for the Colorado Convention Center Capital Maintenance Fund: and

WHEREAS, ordinance 1446, series of 2022 included a cash transfer to the Colorado Convention Center Capital Fund; and

WHEREAS, the budget appropriation in the Colorado Convention Center Capital Fund was mistakenly omitted from the annual appropriation ordinance; and

WHEREAS, this is a corrective action to ordinance 1446, series of 2022 to add the budget appropriation for the Colorado Convention Center Capital Maintenance Fund;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From the Grant and Other Money Project Fund, Accounting No. 38000, out of monies not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1446, Series of 2022, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:

The foregoing appropriation is to support maintenance projects within the Convention Center including facility deferred maintenance for elevators; lobbies and restrooms; carpet, tile, and

1 façade; parking garage; technology; and other maintenance needs that are identified for repairs
2 throughout the year.
