**A BILL**

**For an ordinance authorizing the City and County of Denver to convey to Townhomes on Conejos, LLC, the City’s interest in a parcel of real estate located at 3520 and 3526 West Conejos Place.**

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** That the Mayor and other proper officials of the City and County of Denver be and they hereby are authorized, empowered and directed in the name and on behalf of the City and County of Denver, to convey to Townhomes on Conejos, LLC, by Quit Claim Deed, its interest in a parcel of real estate located at 3520 and 3526 West Conejos Place, in the words and figures contained and set forth in accordance with that form of Quit Claim Deed, filed in the Office of the City Clerk of the City and County of Denver on the 9<sup>th</sup> day of March, 2020, Filing No. 20200030, and to execute said deed according to the terms thereof.

**Section 2.** That the Director, Division of Real Estate, and his designees are hereby authorized, empowered and directed in the name and on behalf of the City and County of Denver, to sign any related documents needed to complete this transaction.
