This contract is for a non-competitive sole source agreement between Johnson Controls, Inc (JCI) and Denver International Airport (DEN) to provide facility operations and maintenance services at the South Campus Data Center (SCDC) and Concourse A Data Center (CADC) that provide maximum equipment and systems uptime within The Uptime Institute's Tier III Concurrent Maintainability requirements, while optimizing energy efficiency, and providing a high level of performance of the cooling and power infrastructure of the Data Center.

The contract term is for 3 years, plus one option to extend two additional years. The initial contract amount is \$4,858,133.

**Scope of work:**

Facility operations and maintenance services at the South Campus Data Center and the Concourse A Data Center that provide maximum equipment and systems uptime within The Uptime Institute's Tier III Concurrent Maintainability requirements, while optimizing energy efficiency, and providing a high level of performance of the cooling and power infrastructure of the Data Center. Services include dedicated on-site personnel, 24x7x365 remote monitoring services using the proprietary Metasys system, emergency response, system lifecycle management, and weekly status reporting to include overall system performance and critical events.

**Was this contractor selected by competitive process?** No **If not, why not?** This procurement qualifies for exception under Memorandum No. 8B and will not be competitively procured. DEN advertised an RFI to assess the market of viable maintenance providers to support DEN's data center facilities. DEN received two responses of which only Johnson Controls Inc. (JCI) demonstrated ability to meet the scope of maintenance required. JCI is the designer and manufacturer of the proprietary equipment and software installed in the DEN data centers.
