CB11-0632 ORDINANCE NO. **COMMITTEE OF REFERENCE:** SERIES OF 2011 Health, Safety, Education, and Services A BILL For an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the United States of America concerning the "Shelter Plus Care Rental Assistance-

Scattered Sites FY11-12" program and the funding therefor.

**WHEREAS**, pursuant to Denver Revised Municipal Code (DRMC) Section 20-52, inasmuch as the Shelter Plus Care Rental Assistance-Scattered Sites program for fiscal year 2011, in combination with the Shelter Plus Care Rental Assistance-Scattered Sites for fiscal year 2012, will exceed \$500,000; and

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement;

## NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

**Section 1.** The proposed Grant Agreement, under CFDA No. 14.238, between the United States of America and the City and County of Denver, which is identified as Grant Number CO0050C8T031003, a copy of which is duly filed with the City Clerk, Filing No. 11-692, be and hereby is approved in all respects.

**Section 2.** The Mayor or his lawful successor and other proper officials of the City and County of Denver, in its behalf, are hereby authorized and directed to execute said Grant Agreement and the Clerk and Recorder of the City and County of Denver is hereby authorized and directed to attest and impress the official seal of the City and County of Denver on the Grant Agreement.

**Section 3.** The Mayor, his successor in office, or his duly authorized representatives, and other officials of the City are hereby authorized and directed to do all things required to be done in order to obtain payments under the Grant Agreement, including, but not limited to, filing requests for payments, contracting with persons and organizations in order to carry out the provisions of the Grant Agreement, filing reports and keeping records relating to fiscal and evaluation matters, and forwarding other materials to the United States of America.
