## **EXECUTIVE SUMMARY**

The purpose of the resolution is to set a public hearing on the Service Plan for the formation and establishment of two (2) Title 32 metropolitan districts: South Sloan's Lake Metropolitan District (MD) #1 (Coordinating District) and South Sloan's Lake MD #2 (Financing District).

The Metropolitan Districts are comprised of approximately 27 acres and are located 2.5 miles west of Downtown Denver's Central Business District primarily on the former campus of the St. Anthony Central Hospital in the West Colfax neighborhood. The districts will be generally located South of 17<sup>th</sup> Avenue, North of Colfax Avenue, West of Perry Street and East of Stuart Street.

The **Coordinating District** is responsible for managing, implementing and coordinating the financing, acquisition, construction, completion, operation and maintenance of all public infrastructure and services within and without the Project. The **Financing District** will pledge all special property tax revenue generated within its boundaries in support the activities of the Coordinating District.

State law requires that a public hearing be conducted prior to City Council approving a service plan, with publication to commence a minimum of 20 days prior to the hearing. The hearing for Service Plan of the proposed South Sloan's Lake MD #1 & #2 are anticipated to be August 5, 2013. The St. Anthony's Urban Renewal Plan Ordinance Request, Cooperation Agreement and Hearing are on the same City Council Schedule as the proposed Metro District.
