6. **General description of proposed ordinance including contract scope of work if applicable:** This is a Grant/IGA with Colorado Department of Transportation (CDOT) to contribute funding to construct detached sidewalks on the east side of Sheridan Boulevard from north of W 8th Ave to W 10th Ave and from just north of Colfax to W 17th Ave. The project will include retaining walls, new curb ramps, landscape restoration, fence replacement, curb and gutter, access control, and drainage improvements. A Minimum of 20 bike spaces will be provided within the immediate project area.
