6. General description of proposed ordinance including contract scope of work if applicable:

The Budget and Management Office is requesting an ordinance to amend Ordinance 841, Series 2015 regarding the establishment of the Police/Fire Special Revenue Fund. Specifically, this amendment will change the Police/Fire Pension SRF, fund number 12824, to an appropriated fund. This will ensure the City commits to stay within the appropriated amount budgeted every year, while ensuring the pension contributions are funded regardless of the revenue generated by the mills. In 2016, the City established a Special Revenue Fund to account for the revenue generated by the Police and Fire Pension mills. The City estimates that the funds generated by the mills will be sufficient to pay for the old hire Annually Required Contribution (ARC) and the 8% employer contribution for new hire police and fire pension contributions. The goal is to use the available funds in excess of the old hire pension contributions to pay for new hire police and fire pension costs which is consistent with the intent of the mills establishment.

Sixteen years ago, \$100k was transferred from the General Fund to a newly created Police/Fire Special Trust Fund (56720) in case there were costs associated with changes made to the Old-Hire Police Pension (related to benefits for surviving dependents). These funds will now be transferred to the new Police/Fire Special Revenue Fund, and the old Trust Fund will be closed.

This is a companion ordinance to the 2017 Long Bill.
