
6 **For an ordinance relinquishing 1) the easements, in their entirety, reserved in**

12 the City and County of Denver has found and determined that the public use, convenience and  
13 necessity no longer requires the easements in the above-referenced Ordinances, and subject to  
14 approval by ordinance, has relinquished the same;

19 202215717, Series of 2022, recorded with the Denver Clerk & Recorder at Reception No.  
20 2022150049, be and the same are hereby approved and that the easements in the above-described  
21 Ordinances are hereby relinquished.
