17 **Section 1.** That the Council of the City and County of Denver hereby approves and

20 Thousand Dollars and No Cents (\$160,000.00) to be issued in two separate checks with one
21 payment issued in the amount of Forty Eight Thousand Dollars and Zero Cents (\$48,000.00) made
22 payable to the Denver Probate Court and a second payment in the amount of One Hundred and
23 Twelve Thousand Dollars and Zero Cents (\$112,000.00) made payable to Killmer, Lane &
24 Newman COLTAF Client Trust Account, in full payment and satisfaction of all claims related to Civil
25 Action No. 19-cv-02437 in the United States District Court for the District of Colorado.

26 Payment to be made upon the execution and delivery of such release or releases as is or
27 are satisfactory to the attorney for the City and County of Denver.

28 **Section 2.** The Manager of Finance is hereby authorized and directed to make such book
29 and record such entries and to do such other things as may be necessary to accomplish the
30 purposes of this resolution.
