**A RESOLUTION**

**Laying out, opening and establishing as part of the City street system a parcel of land as Curtis Street located near the intersection of Curtis Street and 5th Street.**

**WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of the City and County of Denver has found and determined that the public use, convenience and necessity require the laying out, opening and establishing as a public street designated as part of the system of thoroughfares of the municipality that portion of real property hereinafter more particularly described, and, subject to approval by resolution has laid out, opened and established the same as a public street;

**BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** That the action of the Executive Director of the Department of Transportation and Infrastructure in laying out, opening and establishing as part of the system of thoroughfares of the municipality the following described portion of real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:

**LAND DESCRIPTION – STREET PARCEL**

A PARCEL OF LAND LOCATED IN THE SOUTHWEST QUARTER OF SECTION 33, TOWNSHIP 3 SOUTH, RANGE 68 WEST OF THE 6TH PRINCIPAL MERIDIAN, CITY AND COUNTY OF DENVER, COLORADO, AND CONVEYED TO THE CITY AND COUNTY OF DENVER BY QUITCLAIM DEED RECORDED NOVEMBER 10, 2011 AT RECEPTION NUMBER 2011127709 IN THE OFFICE OF THE CLERK AND RECORDER OF THE CITY AND COUNTY OF DENVER, COLORADO, DESCRIBED THEREIN AS:

COMMENCING AT THE SOUTH QUARTER CORNER OF SAID SECTION 33 (A FOUND 3 ¼" ALUMINUM CAP STAMPED "MERRICK PLS 13155 2002");

WHENCE THE SOUTHWEST CORNER OF SAID SECTION 33 (A FOUND 3 ¼" ALUMINUM CAP STAMPED "MERRICK PLS 13155 1988) BEARS S 89°47'14" W A DISTANCE OF 2644.35 FEET (BASIS OF BEARING – ASSUMED);

THENCE N 65°41'04" W A DISTANCE OF 490.30 FEET TO THE WESTERLY RIGHT-OF-WAY LINE OF 6TH STREET AS SHOWN ON THE WEST DENVER SUBDIVISION RECORDED IN

1 THE CITY AND COUNTY OF DENVER CLERK AND RECORDER'S OFFICE, BEING THE POINT  
2 OF BEGINNING;  
3 THENCE S 30°31'07" E, COINCIDENT WITH SAID WESTERLY RIGHT OF WAY LINE, NON-  
4 TANGENT WITH THE FOLLWING DESCRIBED CURVE A DISTANCE OF 73.30 FEET;  
5 THENCE, COINCIDENT WITH THE SOUTHERLY LINE OF A PARCEL OF LAND DESCRIBED IN  
6 RECEPTION NUMBER 910009795, RECORDED FEBRUARY 7, 1991 IN THE CITY AND  
7 COUNTY OF DENVER CLERK AND RECORDER'S OFFICE, ALONG THE ARC OF A CURVE  
8 TO THE LEFT, HAVING A CENTRAL ANGLE OF 12°38'52", A RADIUS OF 453.34 FEET, A  
9 CHORD BEARING OF N 47°27'38" W A DISTANCE OF 99.87 FEET, AND AN ARC DISTANCE  
10 OF 100.07 FEET;  
11 THENCE S 83°08'17" E NON-TANGENT WITH THE LAST DESCRIBED CURVE A DISTANCE  
12 OF 36.62 FEET TO THE POINT OF BEINNING.

13 CONTAINING 883 SQUARE FEET, (0.020 ACRES), MORE OR LESS  
14 be and the same is hereby approved and said real property is hereby laid out and established and  
15 declared laid out, opened and established as Curtis Street.

16 **Section 2.** That the real property described in Section 1 hereof shall henceforth be known  
17 as Curtis Street.
