A BILL

For an ordinance making an appropriation to the Denver Preschool Program Special Revenue Fund and the means for authorizing expenditures from such fund.

WHEREAS, the City desires to appropriate revenue received in excess of the original appropriation for the Denver Preschool Program for 2012;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Monies received from program sales, use tax revenues or other program incomes, including interest earnings, shall be deposited into the Treasury of the City and credited to Special Fund No. 11000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 2. There is hereby appropriated to the appropriation account hereinafter designated the amounts of money following each such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:

The foregoing appropriation is for providing funding to all Denver families, regardless of income, to pay for their children to attend a high-quality preschool of their choice.

3 necessary to accomplish the purposes of this Ordinance.
